Who needs a Canadian Boat Operator Card?

When do I need to get a card? NOW!

The Competency of Operators of Pleasure Craft Regulations require **all operators** of pleasure craft fitted with a motor and used for recreational purposes to have proof of competency on board at all times

Do I need proof of competency to operate a non-powered pleasure craft?

No. The License only applies to pleasure craft fitted with a motor.

If my child is 11 years old and drives a boat of less than 10 HP (with my direct supervision) do they still need proof of competency?

Yes. The age-horsepower restrictions were developed under the Boating Restriction Regulations and aren't affected, or superseded, by the Competency of Operators of Pleasure Craft Regulations. The two are entirely separate regulations and their respective requirements should be looked at separately to avoid confusion.

How do I replace my lost Pleasure Craft Operator Card?

While Transport Canada administers the regulations - all cards are issued by private sector organizations referred to as "Course Providers". Here are a few tips to getting a card replacement:

- First, contact the accredited course provider that originally issued the card.
- Second, if you can't remember the name of the course provider that originally issued your card there are a few things to do to help to remember:
- Did you take the test with a family member or friend? If so, check with them as the name of the course provider will be on their card.
- Did you keep a copy of your receipt or the letter that came in the mail with your card attached to it? The course provider's name is included on both of these documents and...
- Most importantly, Transport Canada recommends that *all* boaters make a copy of their card upon receiving it. This will eliminate doing any research in order to get a replacement card. It's the simplest and most effective way to get your card replaced!

How do I obtain a Pleasure Craft Operator Card?

To obtain a Pleasure Craft Operator Card you need to pass an accredited test.

Do I need to take a course before I write the test?

Taking a boating safety course is strongly recommended regardless of age or experience. However, you can challenge the test without taking a course.

What is covered in a course?

The course covers a full range of basic boating information such as:

- minimum safety equipment requirements required on board your boat;
- the Canadian Buoy system;

- how to share waterways;
- a review of all pertinent regulations;
- and how to respond in an emergency situation.

What are my options?

Take the course over the Internet Online, or in class, or, purchase a training manual from an accredited training organization, study on your own and then take the test.

If I don't pass the test, can I try again?

The test can be written as often as required, although it is strongly recommended that a course be taken if you are unsuccessful the first time. The test can be written only once in every 24-hour period.

Does Transport Canada or the Canadian Coast Guard teach boating safety courses or offer testing?

No. Private companies administer all courses and tests and issue all cards

Isn't an operator card just another word for a licence?

No, unlike a driver's licence, the operator card cannot be revoked and is good for life. Get your Ontario Boating License Today.

What are CLCA members saying about boating on our web forum?

- "...A boat will produce a LARGER wake at a slower speed with the bow in the air ... say 10-20 mph than it does at 25-30 mph ... which can really rock docks and toss smaller boats around in channels and bays ...maybe newer captains can look behind them a bit more while out enjoying the lake, just to make sure that their wake isn't causing any issues to others around them ..."
- "....There are a couple of big wake board boats in our bay who head out to the main body of the lake to do their thing which everyone really appreciates for sure...... there's a substantial difference between being on plane vs. plowing....much better on fuel, less punishing on the motor, docks and shoreline..."
- "...Whenever we wakesurf (which requires huge wake at very slow speed, and ballasts only full on one side), we're always out in the main lake as far from the shores as possible. While it's a compromise for rougher water, we know that we've got a boat that can easily topple floating docks, and create enemies even faster"
- "...With our own dock last year we had more of an issue with boat wakes created by tubers, rather than with wake boarders / skaters / surfers.....all those donuts in one spot at low speed can create huge rollers."
