# Review of Oct 12<sup>th</sup> meeting minutes:

Action items from previous minutes -

Recognition signs to be installed with anchors on rocks at the new welcome signs on the Crystal Lake and Galway Roads

### Membership:

- -We have 185 paid members
- -\$3700 in membership fees were paid in 2013
- -Prepaid memberships; Sarah and Don are to reconcile pre-paid memberships to ensure we have an accurate accounting of these. Sarah and Don will each retain a complete list of pre-paid memberships
- -Beginning in 2014, membership cards will be provided to each member with name and the year of membership. We will be able to provide this by e-mail for most people and by mail to those that do not have access to e-mail. Prepaid members will be sent one card annually for each year that they are paid for.

### Advertisers:

# Fire pump:

#### Triathlon:

- -Sharon is to send a letter to the Township requesting permission to use Township roads and White's Beach
- Chris and Sharon will provide further updates after the next Triathlon team meeting

# **Draft Comprehensive Zoning By-law:**

- -Carl made a presentation to Council on behalf of the CLCA, related to the following;
  - -elimination of the 1000' back lot provision CLCA feels this should remain in place
  - -boathouse set-back CLCA feels that the 50' set-back should remain in place
  - -70' water yard set-back being changed to 100' CLCA feels that a 100' set-back is excessive and should remain at 70'
  - -wording related limited service locations CLCA supports the wording change proposed by the Cavendish Cottagers' Association
- -A meeting is planned early in the new year between Twp. Officials and the Consultant for a further review -Carl will stay abreast of this issue

# Not For Profit Corporations:

- -FOCA has created a kit to assist cottagers' associations in structuring their organizations to meet the proposed new law for "not for profit" corporations
- -CLCA will buy the FOCA kit when/if the legislation comes into force through Provincial Government

### Crystal Lake Map:

- -Gord Rhodes (employee at Pro-Print), has volunteered to create a new electronic map of Crystal Lake which CLCA will be able to keep up to date as required.
- Gord is in the process of obtaining current versions of maps for our area and will 'draft' up a version of the map for us to review and make additions etc. Once finalized, the maps may be printed and made available for sale to members and others
